

GENERAL RULES FOR ADMISSION TO THE CEPT BOYS HOSTEL – 2022-23

1. Hostel Facility will be provided based on first come first serve. Out stationed students will be given priority at the time of allotment of rooms.
2. The hostel inmates shall regularly pay hostel fees at the beginning of every semester as communicated to them from time to time on hostel notice board or via email. The payment dates of the hostel fee shall be same as that of the university fee payment unless otherwise communicated.
3. The hostel shall be allocated to only those candidates who have registered in that academic semester of the university. Any other provision of allocation of hostel shall be subject to due and prior approval of the Rector.
4. A student shall only occupy the room and seat allotted to him in the Hostel and shall not change room.
5. Use of heaters, Water Cooler / Washing Machine gadgets is strictly prohibited. Any unauthorized electrical equipment shall be confiscated by the hostel authority and shall be returned once you vacate the hostel.
6. No playing of the music system shall be allowed between 10:00 PM to 7:00 AM. Any complaint in this regard shall be dealt with strictly.
7. Inmates shall be responsible for any damage done to the building or any other article of the hostel and will be required to pay the damages as decided by the management. Strict disciplinary action shall be taken for any type of vandalism.
8. No guests are permitted to reside in the hostel without the permission of the Rector.
9. Residents must take care of their own belongings. Suspicious persons inside hostel premises must be immediately brought to the notice of the hostel authority.
10. It is the responsibility of the hostel inmates to treat every fellow student fairly. Bullying of any kind will lead to immediate cancellation of hostel facility if found guilty.
11. Students are expected to keep their room clean and hygienic. In spite of regular fogging and other measures to maintain hygienic premises, it is advisable to take personal precautions.
12. Members of the CEPT Hostel Management Committee or any other official of CEPT University have the right to inspect any hostel room at any time.
13. Any inmates while vacating the hostel, either after completion of his studies or while for **practical training/project training** for any other reason for a full semester or more, shall immediately inform the authority in writing. Failing this, the inmates shall be required to pay the hostel charges for that semester.
14. No student shall be allowed to stay in a hostel beyond the duration of their course e.g. 5 years for UG students and 2 years for PG students. Students who need to extend their study duration beyond the prescribed limit shall duly get written approval from the rector in order to avail hostel facility.
15. Students who have not registered with CEPT University for UG and PG are also not eligible for hostel facility.
16. A fine of Rs. 200.00 shall be levied per day for non-payment of fees after each semester registration.
17. Notwithstanding the rule mentioned above, the management has the right to modify/delete/replace any of the rules as and when felt necessary and all the students using hostel facilities shall have to abide by the same.
